**Adopting The Interlocal Purchasing System (TIPS)  
National Cooperative Purchasing Program Application For Use In  
Mt. Diablo Unified School District's Purchases**

WHEREAS, Mt. Diablo Unified School District, pursuant to the authority granted by the State of California purchasing requirements under Government Code §6500, et seq., desires to participate in The Interlocal Purchasing System, hereafter know as TIPS; and

WHEREAS, TIPS is a National Cooperative Purchasing Program offered by Region VIII Education Service Center, located in Pittsburg, Texas, (Camp County); and

WHEREAS, Participation, through membership and utilization of competitively bid and awarded vendor contracts in a cooperative purchasing program specializing in the management of high quality cooperative procurement solutions will be beneficial to the District through the anticipated savings to be realized by such entity listed above; and

WHEREAS, California law enables schools districts and joint power agencies to actively control procurement and to acquire products needed for use in their respective facilities and to establish a coalition to accomplish those ends; and

WHEREAS, the governing Board of MT. DIABLO UNIFIED SCHOOL DISTRICT has considered the proposed Agreement with TIPS, a draft of which attached to the docket, under which the District will become a member of the TIPS Cooperative Program; and

WHEREAS, This legal document will remain current on file until either party severs the agreement; and

NOW, THEREFORE BE IT RESOLVED, that Mt. DIABLO UNIFIED SCHOOL DISTRICT has identified a stated need for participation in THE INTERLOCAL PURCHASING SYSTEM (TIPS) program.

WHEREBY The Governing Board authorizes the Superintendent, Chief Business Officer, or designee to appoint District's Purchasing Director, or person with equivalent duties and background in procurement, who shall serve as the authorized representative to The Interlocal Purchasing System (TIPS), to assess the awarded bids within the program to be used by District, as needed.

WHEREBY Superintendent, Chief Business Officer, or designee is authorized and directed to sign and deliver any and all necessary documents herewith for and on behalf of above named entity requesting membership in TIPS.
