SCOPE OF WORK

WORK DETAILS:

Quality Sound will furnish and install all wiring and modules for the following project,

1. Remove all existing THHN underground fire alarm wiring
2. Install new Aquaseal wire to the following buildings and install addressable modules to monitor the fire alarm devices in the buildings, this is contingent on the underground conduit being in good shape and allowing for the pulling of new cable.

Admin Building

1. No changes and will remain the same.

Building 300

1. Install 1 Siga-UM and 1 Siga-CT2 Modules.
2. H/S circuit will be fed from building 400 power supply.

Building 400

1. Install 1 Siga-UM and 3 Siga-CT2 Modules.
2. Install 1 BPS-10A power supply for H/S circuits.

Gym Building

1. Install 1 Siga-UM and 2 Siga-CT2 Modules.
2. Install Terminal strips and clean up STC.
3. Determine wire path to building devices.

Building 500

1. Install 1 Siga-UM and 1 Siga-CT2 Modules.
2. H/S circuit will be fed from building 600 power supply.

Building 600

1. Install 1 Siga-UM and 1 Siga-CT2 Modules.
2. Install 1 BPS-10A power supply for H/S circuits

Building 700

1. Install 1 Siga-UM and 1 Siga-CT2 Modules.
2. H/S circuit will be fed from building 600.

7. Trip charges apply to all projects regardless of the site's proximity to Quality Sound's place of business.
8. Per Diem shall be applied to any project in which the one-way trip drive time between the site and Quality Sound's place of business exceeds (2) hours.
9. Quality Sound shall be given full access to all areas associated with Quality Sound's work (any necessary keys shall be supplied to Quality Sound's installer).
10. Quality Sound holds the right to bill for any delays or accelerations outside of the control of Quality Sound.
11. All changes to the contract shall be subject to all the above requirements.
