RESOLUTION NO. 19/20-56:

OF THE GOVERNING BOARD OF THE MT. DIABLO UNIFIED SCHOOL DISTRICT AUTHORIZING THE DEDICATION IN FEE TO COUNTY OF CONTRA COSTA FOR STREET PURPOSES

WHEREAS, the Mt. Diablo Unified School District ("District") is the owner of certain real property located at 1700 and 1750 Oak Park Boulevard and the adjacent Pleasant Hill Middle School, One Santa Barbara Road, Pleasant Hill, CA 94523 (collectively the "District Property");

WHEREAS, the County of Contra Costa (the "County") has requested from the District a dedication in fee of approximately 0.03 acres to the County for road, street, and sidewalk purposes (and abutters' rights, if needed) (hereinafter collectively referred to as the "Street Dedication"). A legal description and map depicting the location of the Street Dedication is attached hereto as Exhibit "A" and incorporated herein;

WHEREAS, the District desires to provide the Street Dedication to the County for the construction of roads, streets, sidewalks, and abutter's rights of access;

WHEREAS, the District and community will benefit from the dedication of the Street to the County by allowing the County to construct curbs and drainage improvements that will benefit all property owners along Monticello Avenue, which is adjacent and gives access to Pleasant Hill Middle School;

WHEREAS, on April 13, 2020, the District's governing board, in a regular open meeting, by a two-thirds vote of all its members adopted Resolution No. 19/20-49 (the "Resolution") declaring its intention to dedicate the District Property (attached hereto to Exhibit A);

WHEREAS, the District's governing board fixed May 11th, 2020, for a public hearing ("Public Hearing") upon the question of making the dedication of the dedication in fee to the County;

WHEREAS, the District posted copies of the Resolution in three public places in the District not less than ten (10) days before the Public Hearing, and published notice once, not less than five days before the Public Hearing, in a local newspaper;

WHEREAS, on May 11th, 2020, at a regular meeting of the District's governing board, the District held a Public Hearing upon the question about making the dedication of the District Property to the County; and

WHEREAS, no objection has been filed with the District's governing board.

NOW, THEREFORE, THE GOVERNING BOARD OF THE MT. DIABLO UNIFIED SCHOOL DISTRICT DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

Section 2.	The District's governing board authorizes and directs the	Secretary of the
Governing Board to	take whatever action is necessary to complete the dedicatio	n of the District
Property to the Coun	ty.
