- Template includes fiscal data from the federal CARES Act and budgeted expenditures for high needs and underserved students in the 2019-2020 Local Control Accountability Plan (LCAP.)
- Overview must be approved by December 15, 2020, in conjunction with the first interim budget report



 - Local funds




LCFF Overview

Due to COVID-19 Pandemic, Mt. Diablo Unified pivoted to a full distance learning model starting March 16, 2020 which is projected to continue into January 2021 of the 2020-2021 school year.

The difference between the *budgeted* and *actual* LCFF Supplemental expenditures was significantly impacted by not being able to provide in-person supports and resources for students, staff and families.

LCFF Budget Overview for Parents vs. First Interim Report



The **LCFF Budget Overview** for parents is a communication tool that provides a *brief* overview of the funding sources related to LCAP/LCFF/LCP:

- Total projected general fund revenue to include Local Control Funding Formula (LCFF) supplemental and base funding
- All other state and federal funds, and Coronavirus Aid, Relief, and Economic Security (CARES) funding
- Total budgeted expenditures reflected in the Learning Continuity and Attendance Plan
- Total budgeted expenditures for high needs students that are reflected in the 2019/2020 LCAP

The First Interim Report

- Reflects the financial and budgetary status of the District as of October 31, 2020.
- Provides significant financial and budget detail for all funding sources
- Includes an Multi Year Projection Report that shows the financial projections for the current and subsequent two (2) fiscal years.
- The Governing Board is required to certify to the District's ability to meet its financial obligations for the current and two (2) succeeding fiscal years
