**RESOLUTION OF REDUCTION OR DISCONTINUANCE
OF CLASSIFIED EMPLOYEES (CLASSIFIED LAYOFF)
Resolution No. 14/15-44**

WHEREAS, Education Code sections 45101, 45114, 45117, 45298, and 45308 authorize the District to layoff classified employees for lack of work and/or lack of funds upon sixty (60) days prior notice, and

WHEREAS, due to lack of funds or lack of work, this Board hereby finds that it is in the best interest of Mt. Diablo Unified School District that certain services now being provided by said school district be discontinued by the following extent.

NOW, THEREFORE, BE IT RESOLVED, that as of the 20th day of April, 2015, the positions listed here to be reduced or eliminated; and

BE IT FURTHER RESOLVED, that the District Superintendent or designee be authorized and directed to give notice of termination of employment to the affected employee(s) of this District pursuant to District rules and regulations and applicable provisions of the Education Code not later than the sixty (60) days prior to the effective date of such reduction or discontinuance as set forth above.

BE IT FURTHER RESOLVED, that the District Superintendent or designee be authorized and directed to take any other actions necessary to effectuate the intent of this resolution.

BE IT FURTHER RESOLVED, that the district administration be and hereby is authorized and directed to notify the employee(s) affected by this action and to layoff or reassign employees in accordance with District policy and procedures.
