Mount Diablo USD - Purchasing Warehouse, Sprinkler Monitoring System

SCOPE OF WORK

The scope of this project is to expand the existing EST3 fire alarm system from the addressable signaling line circuit and existing booster power supply located in the fire riser room of the Nutrition Warehouse to the Purchasing Warehouse for sprinkler monitoring. The Purchasing Warehouse sprinkler monitoring system will consist of monitoring the new sprinkler waterflow, valve tamper and post indicator valve switches, new pull stations at the main front, rear office and main warehouse exit doors. Each office area will receive horn/strobe notification throughout per code requirement and supplemental (ancillary coverage, not full coverage) notification in the warehouse. The existing EST3 fire alarm control panel is located in the main electrical room for the maintenance and operations building. Quality Sound will pull all wire for the sprinkler monitoring system in raceway provided by the district's preferred electrical contractor.

Quality Sound's Scope of work:

- Provide all equipment per plans and specifications for systems quoted.
- Provide and Pull all wire and cable for systems quoted only.
- Provide specialty back boxes only for systems quoted only.
- Final connect at terminal cans and head-end for systems quoted.
- All required tests and guarantees as quoted.
- Submittals and Drawings in a timely manner as not to impact the schedule.
- Tax and normal freight included in price.
- Device Installation for systems quoted.
- Providing of boom/scissor lifts for installation and testing of system devices is included.

Work to be done by others: (Exclusions from Quality Sound's scope of work):

- · Provide and Install all conduit, surface raceway, non-specialty back boxes, and terminal cans per Approved prints.
- All raceway shall be provided with pull strings/ropes and a complete set of as-built drawings.
- Any associated fees and permits cost is excluded.
- Installation of all back boxes including specialty back boxes is excluded.
- · Providing and installing all forms of raceway is excluded.
- Providing and Installing, Cable Trays, Wire Baskets, and back boards is excluded.
- Providing and installing access doors, fire stop sleeves and fire caulking is excluded.
