## REPORT OUT ACTION TAKEN IN CLOSED SESSION

In Closed Session, the Board received information relative to a personnel matter, and took action to release a second round of documents in response to the Public Records Act request of Dan Borenstein of the Contra Costa Times. In the matter of Public Employee Discipline/Dismissal/Release/Complaint for two Certificated Employees #12428 and #13977, the Board provided staff with direction.

In the matter of Public Employee Discipline/Dismissal/Release/Complaint of employee #22936, the Board voted 3-2-0 to end the employment of the Superintendent on a Without Cause basis on or before May 1, 2013. The Board took further action in a 5-0-0 vote on a separation agreement with the Superintendent, and has agreed to the terms of the separation agreement upon final review by the Board's independent counsel.

In the matter of Public Employee Discipline/Dismissal/Release/Complaint of employee #28941, the Board voted 4-1-0 to end the employment of the General Counsel on a Without Cause basis on or before May 1, 2013. The Board took further action in a 5-0-0 vote on a separation agreement with the General Counsel, and has agreed to the terms of the separation agreement upon final review by the Board's independent counsel.

President Hansen announced that a Special Board Meeting will be scheduled for Sunday, April 28<sup>th</sup> at 8:00 p.m. to sign the final separation agreements. At that meeting the Board will also appoint an Interim Superintendent, and will review a proposal for a search firm to search for a new Superintendent.
