Accomplishments in 2022-23

 Our District-wide 1:1 program for students is now fully implemented and by June, 2023, all teachers will have been issued an up-to-date Windows laptop (Action Steps 2.1.1, 2.1.2)



- A District Education Specification (Ed. Spec.) will be presented to the Board of Education this evening (Action Step 2.1.7)
- An improved "zone system" for more responsive IT support to schools is in operation (Action Step 3.1.2)

Accomplishments in 2022-23

An architectural services plan for network infrastructure at the initial 12 sites will be presented for Board of Education consideration,
March 8, 2023 (Action Steps 4.1.2, 4.1.3, 4.1.4)

 A department reorganization has better aligned IT staffing to the current needs of our sites (Action Step 4.3.1)

 In collaboration with Teamsters, a modernization of three critical job descriptions has improved our ability to recruit and retain IT staff (Action Step 4.3.2)



Accomplishments in 2022-23

- Improved and modernized systems and partnerships for backups, disaster recovery, and cybersecurity protection and response are in place (Action Steps 4.4.2, 4.4.4)
- An Incident Response Plan is in place for Ransomware, with additional plans to be added (Action Step 5.1.3)
- Technology equipment refreshes, including Chromebooks, laptops, desktops, copiers, and printers are underway (Action Step 6.1.1)
- A renaming to the Department of Information Technology (I.T. Department, or just "IT") is complete (Action Step 7.3.2)

Challenges in 2022-23

- Modern asset management (Action Step 2.1.4)
 - o Proposal for a more robust asset management system coming soon
- Educational Technology Coordinator (Goals 1, 2, 3)
 - Hired Erin Vallejo, starts February 27, 2023
- Management tools for Windows devices (Goals 2, 3)
 - Proposal for improved management and streamlined licensing coming soon
- Security improvements (Goal 5)
 - Impact on staff practices



Next Steps and Current Work in the IT Department

- Conduct our annual review of the Technology Strategic Plan
 - Strategic Planning Committee, Spring, 2023
 - Anticipated presentation for Board of Education input, June 14, 2023, with final approval on August 16, 2023
- Network infrastructure plan (to Board of Education, March 8, 2023)
 - Conducted May August, 2023
- Network design (12 Board-Approved Prioritized Sites)
 - o Begins Fall, 2023
- Promote equity through equipment refresh and standardization
 - Copiers are fully deployed
 - Laptops, desktops, printers scheduled for completion by June, 2023
 - Support for nonstandard equipment, such as Apple devices, specialty printers, etc., only based on clear demonstrated need
- Ongoing information and cybersecurity improvements
