



MT. DIABLO UNIFIED SCHOOL DISTRICT GOVERNING BOARD
RESOLUTION 20/21-36
to Establish Regular Meetings for the 2021 Calendar Year

WHEREAS the establishment of meeting dates, to maximize public opportunity for participation, should properly consider potential calendar conflicts of recognized religious observances within the community, with particular attention to those observances which include work restrictions, and

WHEREAS herein those proper considerations have been given in consultation with the national [Anti-Defamation League](#) and local [Jewish Community Relations Council](#), and

WHEREAS virtual meetings, through continuous development, have shown a level of viability and accessibility for the facilitation of district business matching that of physical meetings, and

WHEREAS within this function the minimization or elimination of language barriers shows the value we have for our diverse community,

THEREFORE, BE IT RESOLVED that the Mt. Diablo Unified School District Board of Education establishes and qualifies its regular meetings for the 2021 calendar year as such:

- Meetings shall be held on the second and fourth Wednesdays of each month, with the exception of July, wherein no meetings will be held, and with the exceptions of May, November, and December, wherein only one meeting will be held. These shall be the regular meeting dates of 2021: January 13, January 27, February 10, February 24, March 10, March 24, April 14, April 28, May 12, June 9, June 23, August 11, August 25, September 8, September 22, October 13, October 27, November 10, and December 8.
- Meetings shall include a Closed Session, with no public access, beginning at 5:00PM, and an Open Session, with public access, beginning at 6:00PM.
- Meeting agendas shall be published electronically to mdusd.org/boardmeetings and physically to the district central office, located at 1936 Carlotta Drive, Concord, CA, describing the meeting setting — virtual or physical—and public participation options accordingly, including information about interpretation services.
