DIRECTOR, SECONDARY SUPPORT

Summary Definition

Under the general direction of the <u>Assistant Superintendent, Educational Services, this</u> <u>position</u> is responsible for directing the district's secondary instructional program, coordinating a system of school support including principal coaching, staff supervision, professional development, and providing leadership in the ongoing development and improvement of curriculum and instruction in the District.

- 1. Implement a system of direct support to school sites and administrators to maximize the achievement of all students. $\underline{\mathbf{E}}$
- 2. Support all secondary principals and their school sites. \mathbf{E}
- 3. Assist with the supervision and evaluation of secondary principals. E
- Collaborate with the <u>Director, Elementary Support</u> in coordination and articulation of K-12 programs, curriculum, assessments, professional development, and other services. <u>E</u>
- 5. Work collaboratively with other administrators in the Student Achievement and School Support division to assure coordination, alignment, and articulation of the District programs. **E**
- 6. Monitor the implementation of the District's standards-based curriculum. E

- 7. Initiate and supervise improvement of curriculum, including the development and revision of courses of study. $\underline{\mathbf{E}}$
- 8. Supervise, along with the <u>Director, Elementary Support</u>, the implementation of the District Local Control Accountability Plan (LCAP). <u>E</u>
- 9. Work with principals and District staff to analyze and evaluate the secondary program. \mathbf{E}
- 10. Design and implement a staff development program for secondary administrators. \mathbf{E}
- 11. Plan and lead regular principals' meetings with agendas that include items of philosophy, principles, methods, and worthy developments in education, as well as matters of an operational nature. **E**
- 12. Provide leadership in the resolution of complaints and issues of secondary schools.
- 13. Supervise the textbook adoption processes in cooperation with District staff, principals, teachers, and community members. **E**
- 14. Promote the articulation of curriculum from grade to grade across all district schools. \mathbf{E}
- 15. Supervise the site coordination and management of K-12 categorical programs. \mathbf{E}
- 16. Support the preparation of state and federal project applications.
- 17. Supervise technical support and guidance to sites to comply with district policies, state and federal regulations. $\underline{\mathbf{E}}$
- 18. Supervise administrator assistance and training in federal and state compliance activities.
- 19. Responsible for the management of general fund, categorical and grant budgets which relate to the district curriculum and district program. $\underline{\mathbf{E}}$
- 20. Supervise the organization and administration of the District's intervention efforts including, but not limited to, summer school, PBIS, and other response to intervention programs. **E**
- 21. Monitor the development of the curriculum, selection of materials, selection and training of the staff, enrollment of students and related attendance procedures, communication with parents, and resolution of operational problems. $\underline{\mathbf{E}}$
- 22. Administer the District's Promotion/Retention policies at the secondary level, including the appeal process. $\underline{\mathbf{E}}$
- 23. Stay current on state and federal legislations, mandates, guidelines, and curriculum frameworks and disseminate the information.

- 24. Develop new policies and revise existing District policies on a systematic basis, as needed. Prepare agenda items for the Board meetings, as needed. These will be recommended to the Superintendent for presentation to the Board on a continuing basis.
- 25. Monitor master schedules and coordinate the staffing allocation for secondary schools. $\underline{\mathbf{E}}$
- 26. Take leadership in creating healthful human relationships which will provide a suitable climate for learning and teaching.
- 27. Keep the <u>Assistant Superintendent</u>, <u>Educational Services</u> well informed about issues related to secondary schools and secondary programs.
- 28. Perform other duties as assigned by the **Assistant Superintendent, Educational Services** or Superintendent.

DESIRED QUALIFICATIONS

Knowledge of:

- 1. Knowledge of principles of organization and management.
- 2. Knowledge of curriculum and the operation of elementary and secondary schools, alternative and adult education programs.
- 3. Knowledge of laws, district policies, and regulations pertaining to elementary and secondary education and related programs.
- 4. Knowledge of basic elements of instruction.
- 5. Ability to cope with emergency situations.
- 6. Ability to exercise good judgement and tact.
- 7. Ability to work effectively with all segments of the educational community and general public.
- 8. Ability to speak and write effectively.
- 9. Ability to analyze problems, make decisions or recommendations, and be responsible for these decisions.
- 10. Knowledge of the principles of staff training and development.
- 11. Knowledge of budget development, maintenance, and evaluation.

- 12. Skill in working with diverse groups and individuals in a manner that achieves district goals.
- 13. Skill in translating District policy to various employees, individuals, and groups.
- 14. Ability to supervise and direct a large staff or department.

Skill In:

- 1. Handling confidential information with discretion.
- 2. Establishing and maintaining effective working relationships.
- 3. Interpersonal skills using tact, patience, and courtesy.
- 4. Leadership of teams and departments.

Education and Experience:

Any combination equivalent to:

- 1. Post graduate work in school administration, curriculum and instruction, or a related field.
- 2. Five years of successful experience in increasing responsibility in school administration including successful experience as a principal.
- 3. Experience in districtwide leadership roles.
- 4. Experience in directing/supervising the work of others.
- 5. Experience in staff training and development.
- 6. Possession of an appropriate school administrative credential.

Environment:

<u>District office environment; fast-paced work with deadlines; frequent interruptions and high demand to multi-task and complete job duties with stringent specifications; maintains high regard for exemplary customer service.</u>

Physical Abilities:

Hear and speak to exchange information in person and on the telephone; communicate so others will be able to clearly understand normal conversation; dexterity of hands and fingers to operate a computer keyboard and manipulate paper; see to read, prepare documents and reports; sit or stand for extended periods of time; work at a desk, conference table, or in meetings in various configurations; hear and understand speech at normal levels; kneel, bend at the waist, reach overhead, above the shoulders and horizontally; lift objects weighing up to 25 pounds.
