If you are a member of TIPS/TAPS you may use the following steps to make purchases:

Contact the Awarded Vendor Representative as listed on the vendor page. Identify yourself as a TIPS/TAPS Member to receive the special TIPS/TAPS price.

Compare quotes from multiple TIPS/TAPS Vendors (if desired).
