**Summary:** SPG Therapy & Education is a non-public agency (NPA) that provides speech and language pathologist, occupational therapists, physical therapists, registered behavior technicians, behavior and paraprofessionals for school-based services that are identified on Individual Education Plans (IEP's) and 504 Plans. When Mt. Diablo Unified School District is not able to fill all open positions with district employees, the use of contract agencies is necessary to ensure that we are in compliance with state and federal law that governs special education. SPG Therapy & Education is a company that is utilized to provide these services to ensure that all of our needed services are covered for the 2022-2023 school year. Mt. Diablo Unified School District Human Resources, Student Services and Special Education continues to recruit and hire district employees.

**Funding:** Funding: 12190 Special Education DIS: Speech/Audiology, 12170 Special Education DIS: PT/APE/OT, 16610 Special Education Nonpublic Agencies, 10000 Special Education SDC Operating
